ORDER ON SETTLEMENT AGREEMENT

The official records of the Alcoholic Beverage Control Board (Board) reflect that Rythm & Eats, LLC, t/a Prather's on the Alley, Applicant for a new Retailer's Class CR License, located at 455 I Street, NW, Washington, D.C., and ANC 6E have entered into a Settlement Agreement (Agreement), dated February 6, 2018, that governs the operation of the Applicant's establishment.

The Agreement has been reduced to writing and has been properly executed and filed with the Board. The Applicant and Chairperson Alexander T. Marriott, on behalf of ANC 6E, are signatories to the Agreement.

Accordingly, it is this 7th day of March, 2018, ORDERED that:

1. The above-referenced Settlement Agreement submitted by the parties to govern the operations of the Applicant's establishment is **APPROVED** and **INCORPORATED** as part of this Order, except for the following modification:

Subsection 5(a) – This Subsection shall be modified to read as follows: "During all times, amplified music emanating from the boundaries of the Restaurant's premises (except during times that the doors are open for ingress or egress) shall not be audible in the neighboring community."

The parties have agreed to this modification.

2. Copies of this Order shall be sent to the Applicant and ANC 6E.

Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. Recitations

WHEREAS, Rhythm & Eats LLC ("Owner"), is a limited liability corporation organized under the laws of the District of Columbia, and duly authorized to do business in the District of Columbia; and

WHEREAS, the premises on 455 I Street, NW is located within Advisory Neighborhood Commission 6E ("ANC 6E"); and,

WHEREAS, the Owner has filed for a new Class "C" Restaurant license under the D.G. Alcoholic Beverage Control Act ("Application") with the ABC Board, and,

WHEREAS, the Application seeks approval to operate a new full-service Restaurant ("Restaurant") and Sidewalk Cafe at 455 LSt., NW, and the Application does not include an Entertuinment endorsement; and,

WHEREAS, the Owner and ANC 6E (collectively, the "Parties") desire to resolve potential issues in the operation of Prather's on the Alley located at 455 I Street, NW. ("Restaurant") and enter into this Settlement Agreement in exchange for ANC 6E's support of the Application.

NOW. THEREFORE; in consideration of the recitals set forth above and the mutual covenints and conditions set forth below; the Parties agree as follows:

- 1. The recitals set forth above are incorporated herein by reference.
- 2. Interior Hours of Operation and Hours of Alcoholic Beverage Sales, Service, and Consumption:
 - a) Sunday: through Thursday: 8:00am to 1:00am; and
 - b) Friday and Saturday: 8:00am to 2:00am.

Provided, however (1) on days designated by the ABC Board as "extended Hours for ABC Establishments" Owner may operate and serve alcoholic beverages for one additional hour (that is, one hour later); (2) in the event the Council of the District of

Columbia or the ABC Board grant licensees in general operating hours for particular dates, holidays or events (e.g. inauguration), Owner may avail itself to such extended hours; and (3) on January 1 of each year, Owner may operate and serve alcoholic beverages until 4:00am.

3. Sidewalk Cafe Hours of Operation and Hours of Alcoholic Beverage Sales, Service, and Consumption:

a) Sunday through Saturday: 8:00am to 11:00pm.

- 4. No amplified sound shall be permitted on the Sidewalk Cafe outside the Restaurant.
- 5. Owner-will comply with all D.C. Office Code §25-725:

a) During all times, amplified music shall not exceed [65] dBA as measured at the boundaries of Restaurant premises (except during times the doors are open for ingress and egress).

b) Amplified sound emanating from the licensed premises that is audible in other nearby residential premises, even during ingress and egress, is prohibited.

- 6. At all times Owner agrees to maintain cleanliness of the premises and ensure the Sidewalk Cafe and adjacent public property is free of trash/waste, including the sidewalk in front of the Restaurant and Alleyway (4 % St.) beside the Restaurant. Owner also agrees to remove show and ice from the aforementioned public space within eight daylight hours following the accumulation of snow or ice.
- 7. Owner shall cause extermination services to be provided to the Restaurant by a reputable exterminator on at least a monthly basis.
- 8 Owner agrees to take reasonable steps to respond to residential neighbors' complaints/issues:
- 9. Owner shall take reasonable steps to control and minimize disturbances caused by unruly patrons (e.g. loud, drunken, and/or aggressive behavior), by refusing such patrons admission to the Restaurant and Sidewalk Cofe, or asking such patrons to leave the Restaurant and Sidewalk Cofe as circumstances dictate.
- 10. Support for Application. Upon execution of this Settlement Agreement and its acceptance by the ABC Board, ANC 6E agrees to support Owner's pending ABC license Application and shall retrain from filing a protest against Owner's pending license application.

In witness thereof, the Parties, acting through their authorized representatives, have agreed to and signed this Settlement Agreement.

Advisory Neighborhood Commission 6E conducted a public meeting on Tuesday, February 6, 2018 at the Watha T. Daniel/Shaw Library, 1630 7th Street, NW, to consider the above-referenced matter.

At the Commission's meeting, duly noticed and with this case listed in the notice, with a quorum present (four out of seven Commissioners required to be in attendance to achieve a quorum), ANC 6E voted unanimously (6 in favor, 0 opposed, and 0 abstention) to support the application for a new stipulated Retailer's Class "C" Restaurant ABC license for Rhythm & Eats LLC t/a Prather's on the Alley at 455 I Street, NW. The application does not include an entertainment endorsement.

Prather's on the Alley will be a full-service restaurant with a sidewalk café, and received ANC 6E's support contingent upon the terms of the attached Voluntary Agreement being followed. ANC 6E encourages the ABC Board to approve the application and accept the negotiated terms of the Voluntary Agreement.
