RE: Support for NOI to Convert the 900 Block of 4½ Street NW from Two-Way to One-Way Southbound (NOI 21-202-TESD)

Dear Mr. DeFrank:

On September 7, 2021, at the duly noticed and regularly scheduled meeting of the Advisory Neighborhood Commission 6E ("ANC 6E" or "Commission") and with a quorum of 6 out of 7 Commissioners and the public present, ANC 6E approved the following resolution by a vote of 6 in favor, 0 against, and 0 abstentions:

WHEREAS, the Duties and Responsibilities of the Advisory Neighborhood Commission Act of 1975 grants ANC 6E the responsibility to advise the Council of the District of Columbia, the Mayor, and each executive agency and all independent agencies, boards, and commissions of the government of the District of Columbia with respect to all matters of District government policy, including decisions regarding planning, streets, recreation, social services programs, education, health, safety, and sanitation which affect the ANC 6E area;¹

WHEREAS, DDOT issued a Notice of Intent ("NOI") on August 9, 2021 proposing to convert the 900 Block of 4½ Street NW from two-way to one-way southbound and to install signs and pavement markings to facilitate the one-way conversion (NOI-175-TESD);

WHEREAS, the 900 Block of 4½ Street NW lies within the jurisdictional boundary of ANC 6E in Single Member Districts 6E05;

WHEREAS, ANC 6E has twice passed resolutions requesting that the 900 Block of 4½ Street NW be converted from two-way to one-way southbound -- once on June 6, 2019,² and once again on January 5, 2021;³

WHEREAS, the Mount Vernon Triangle CID is working with DDOT and in coordination with ANC 6E to design safety enhancements to the 900 Block of 4½ Street NW and these safety enhancements are predicated on the conversion of the 900 Block of 4½ Street NW from two-way to one-way southbound;

THEREFORE, BE IT RESOLVED that ANC 6E supports the NOI to convert the 900 Block of 4½ Street from two-way to one-way southbound.
