RE: Resolution in Support of the Application for a New Unenclosed Sidewalk café at 601 New Jersey Ave. NW.

Dear Chairman Garrett and Public Service Committee Members:

On June 6, 2023, at a duly noticed and regularly scheduled meeting of Advisory Neighborhood Commission 6E (“ANC 6E” or “Commission”) conducted virtually via videoconference and with a quorum of 6 out of 8 Commissioners and the public present, ANC 6E approved the following resolution by a vote of 5 for, 0 against, and 1 abstentions:

WHEREAS, the Duties and Responsibilities of the Advisory Neighborhood Commission Act of 1975 grants ANC 6E the responsibility to advise the Council of the District of Columbia, the Mayor, and each executive agency and all independent agencies, boards, and commissions of the government of the District of Columbia with respect to all matters of District government policy, including decisions regarding planning, streets, recreation, social services programs, education, health, safety, and sanitation which affect the ANC 6E area;<sup>1</sup>

WHEREAS, on March 31, 2023, Elisa Bennaton of The Ministry, owner of The Ministry (“applicant”) submitted an application to the Public Space Committee for a New Unenclosed Sidewalk Café at 601 New Jersey Ave. NW (“Application”) which would serve The Ministry;

WHEREAS, 601 New Jersey Ave. NW is located within the jurisdictional boundaries of ANC 6E in Single Member District 6E07;

WHEREAS, the Applicant presented the design for the proposed unenclosed sidewalk café to ANC 6E at its meeting on June 6, 2023;

WHEREAS, in reviewing the café design, ANC 6E expressed no concerns;
