## Re: Convert Alley on Square 451 to One-Way Southbound Traffic Operations

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

## • Conversion of alley on Square 451 to One-Way Southbound

Currently, the alley allows for two-way traffic between New York Avenue and K Street NW. Based on safety concerns and the request from ANC 6E, DDOT has determined to convert the alley on Square 451 to one-way operations in the southbound directions. This alley is located between 600 block of K Street NW and 600 block of New York Avenue NW.
