Purpose of the E Street CAT

DHS will be working with ANCE 6E to develop the E Street Community Advisory Team (CAT). The CAT is a partnership between DHS, Miriam's Kitchen, ANCs, Civic & Tenant Associations, and facility residents. The CAT will develop a Good Neighbor Agreement that will outline their shared goals and the responsibilities of the partners. As the community's official voice, a CAT ensures residents are informed, engaged, and empowered—fostering trust and collaboration between DHS and the neighborhood.

Key Roles of the CAT

- Acts as the official stakeholder voice for the community.
- Ensures transparent communication and timely information-sharing with residents.
- Builds partnerships between DHS and local organizations to support shared goals.
- Promotes community accountability and collaborative problem-solving.
