**8. REQUEST FOR SUPPORT FOR EXTENSION OF PLANNED UNIT DEVELOPMENT (PUD) WITH THE D.C. ZONING COMMISSION FOR THE CAPITOL CROSSING CENTER BLOCK**

**MOTION:** The Commission voted (6 yeas – 0 nays – 0 abstentions) on a resolution that SUPPORTS the request for the two-year time extension of the approved second stage Planned Unit Development (PUD) for Zoning Commission Cases 0834L and 0834M and express that support to the Zoning Commission. **9. UPDATE ON THE CENTRAL CELL BLOCK PROJECT AT 501 NEW YORK AVENUE NW FROM THE D.C. DEPARTMENT OF GENERAL SERVICES (DGS) AND THE D.C. DEPARTMENT OF CORRECTIONS (DOC)**

DGS narrated a slide presentation that presented an update on the following topics: Summary of Work from July 2025 to November 2025, Regulatory Review Updates, Current Design Elements Under Review, Schedule Update and What to Expect Next. A question-and-answer/comment period followed.

**10. VOTE ON PROPOSED RESOLUTION THAT: 1) ENCOURAGES DDOT TO TRANSFER OWNERSHIP OF THE SITE TO THE DEPARTMENT OF PARKS AND RECREATION; AND 2) SUPPORT THE CONVERSION OF OPEN SPACE INTO A DOG PARK IN SINGLE-MEMBER DISTRICT 6E09**

**MOTION:** The Commission APPROVED (6 yeas - 0 nays – 0 abstentions) a resolution that encourages the District Department of Transportation (DDOT) to transfer the ownership of the site in front of 400 Massachusetts Avenue to the Department of Parks and Recreation (DPR), and then to convert or develop the site into a dog park and to preserve the trees on the site to the extent possible. (Motion by Commissioner Hans, Second by Commissioner Alhadeff).

- Commissioner Hans proposed asking Karen Jehle to see if she would be interested in typing the Annual Report and helping to write out resolutions going forward, sending said resolutions for review to the commissioners who made them and then sending them to the Chair for signature. - Commissioner Prince stated DDOT is convening public workshops to discuss the Strategic Bikeways Plan ward by ward and Ward 6's meeting will be on December 3, 2026 at the Southwest Library at 900 Wesley Place SW from 6:00 p.m. to 9:00 p.m.
